Thanks Amber. I corresponded with Alder Vanderkin today regarding the sign code. Please wait until either you or I hear back from him regarding his sign code concerns before adding that item to the agenda. Your suggestions regarding staff input for the remaining two items makes sense.

We may be able to resolve some of the traffic violation issues with increased enforcement during start and close of school but that will depend on officer availability.

Parking regulations at S. 12th and Washington are currently in place as follows:

South 12th Street.

(a) On the east side of South 12th Street from the south curbline of Washington Street to the north curbline of Marshall Street from 10:00 p.m. to 6:00 a.m.

(b) On the west side of South 12th Street beginning at a point of 128 feet north of the north curbline of Washington Street, thence continuing north a distance of 78 feet, except for the sole purpose of loading and unloading motor vehicles.

I think What the Lock is on the east side of South 12th so if we want to eliminate parking there, we should notify What the Lock and offer them an opportunity to attend PS to discuss.

We don't currently prohibit parking on Washington Street in that area but there is a state law prohibiting parking within 15 feet of a crosswalk (Wis. Stat. 346.53(5)). It looks like the pole is about 50 feet east of the crosswalk line and that stretch is not painted for parallel parking stalls. This may be a good opportunity for an ordinance update but I'd still want Minikel's, What the Lock's and any other impacted business's opinion before making the change.
