Dear Adam,

Enclosed is a resolution and map to order the installation of six (6) each, ornamental, Double-Acorn, LED street light standards to illuminate the 1000 block of Buffalo Street. MPU seeks Common Council approval for the installation per Municipal Code 12.150 and current rates provided by the Public Service Commission of Wisconsin.

Fiscal Impact- given 100% city contribution toward initial installation cost (\$59,900 estimated) \$240 per month fixed charge (\$20 per lamp/month x 12 lamps) plus \$2.80 per month energy = \$2,914 annual total.

RESOLUTION

WHEREAS, City of Manitowoc deems it desirable to install an ornamental lighting system to illuminate the 1000 block of Buffalo Street, and

WHEREAS, Municipal Code 12.150(2)(a) defines ornamental street lighting as a type of lamp that is mounted to a standard or post to which energy is supplied from an underground electrical distribution system or from fixtures of special ornamental design, and

WHEREAS, Municipal Code 12.150(2)(b) provides that the Common Council may order installation of ornamental street lighting upon receipt of a petition by 50 percent or more of the owners of the taxable frontage of any street, or may by resolution provide for the installation of an ornamental lighting system without any such petition, and

WHEREAS, Municipal Code 12.150(2)(c) provides that the installation cost may be paid by the property owners or by the City at its discretion, and

WHEREAS, the installation cost for illuminating the roadway is estimated at \$59,900, as provided in Manitowoc Public Utilities construction cost estimate for this portion of the River Point Development, and

WHEREAS, Municipal Code 12.150(2)(d) provides that the operation and maintenance expenses of the ornamental street lighting system are to be paid from the City's general fund to the Manitowoc Public Utilities according to rates approved and on file with the Wisconsin Public Service Commission, and

WHEREAS, Manitowoc Public Utilities recommends installing six (6) each, 40-Watt, Double-Acorn, ornamental, LED street lighting standards to provide lighting consistent with ANSI RP-8, American National Standard Practice for Roadway Lighting,

NOW THEREFORE BE IT RESOLVED BY THE MAYOR AND COMMON COUNCIL OF THE CITY OF MANITOWOC, that Manitowoc Public Utilities install and maintain six (6) each, 40-Watt, Double Acorn, ornamental LED street light standards in the 1000 block of Buffalo Street.
