In addition to drafting legislation and reviewing contracts as requested by City departments, the City Attorney's Office has worked on the following projects and initiatives since the Mayor's last update dated November 3rd, 2022:

Environmental Remediation

- Lemberger Landfill: Work continues as planned. I have taken the lead going forward.
- Gravel Pit: Godfrey Kahn continues as legal counsel. Watermain project continues.
- Mirro Plant No. 9: Godfrey Kahn is legal counsel for cost recovery efforts.
- WPS Superfund Site: No update.

Open Records Requests

- EPA re the City's Brownfield Program (Adam Tegen is handling).
- Routine open record requests will once again be handled by the City Attorney's Office. They have been handled in the interim by City Clerk/Deputy Treasurer Mackenzie Reed-Kadow.
- Reviewed a request made to MPD where redaction was questioned; MPD handled appropriately.
