Yes, we are open to discussing Lincoln Park signage. How would you like to handle this? Should we simply add this to the Oct. PI agenda for discussion? Do you have any recommendations or examples of what you would like to see in mind...perhaps I can do some research and bring that to the meeting.

We received the completed Maritime Bluff restoration plan from Stantec and presented the plan at PI meeting in Aug. I don't believe you were at that meeting. We have the plan and costs associated to restoring the bluff. At this point we are working with LNRP and Stantec to try and source grant funding to implement the plan. The project estimate is \$130k, unlikely we will be able to secure grant funding to fund the entire project, most grants require city match. At this point Park Dept. has included this project in the budget recommendations but it is up the Mayor and council to make the final decision on what projects make the budget. If this project is a priority for you I believe you will have an opportunity to voice that in the budget process.
