## Report to the Manitowoc Plan Commission

**Request:** PC 2–2023: Annual Review of Community Living Arrangements

**Reason for Request**: Section 15.370(19)b of the Municipal Code

**Report**: Pursuant to Section 15.370(19)b of the Municipal Code, on an annual basis the Plan Commission shall review and the Common Council shall determine whether a community living arrangement's existence poses a threat to the health, safety or welfare of the residents of the City and may take-action, in accordance with State law, to order the discontinuance of said community living arrangement. The office of the City Clerk shall maintain records regarding all community living arrangements.

The City Clerk, Building Inspection and Fire Departments were contacted, and no major complaints or concerns were on file regarding the Community Living Arrangements.

As of January 1, 2022 there are a total of 33 Community Living Arrangements in the City; 9 of which are Adult Family Homes (AFH - 3 or 4 Beds) with a total of 31 beds and 24 Community Based Residential Facilities (CBRF 5 or more Beds) with a total of 512 beds.

Recommendation: Pursuant to section 15.370(19) the Plan Commission has reviewed the Community Living Arrangements and is recommending to the Council to approve the associated licenses for the Community Living Arrangements for 2023.
