

ORDINANCE

An Ordinance to amend Sections 10.170, 10.210, 10.230, 10.410, 10.490, 10.730, and 10.850 of the Manitowoc Municipal Code regulating traffic flow and parking within the River Point District.

The Mayor and Common Council of the City of Manitowoc do ordain as follows:

Section 1. Section 10.170 is amended to read as follows:

“10.170 Through Intersections.

...

North 11th Street.

- (a) Southbound traffic on North 11 Street shall stop before entering York St. or before continuing southbound on North 11th Street.

...

York Street.

- (a) Traffic entering North 6th Street from York Street shall stop before entering North 6th Street.
- (b) Westbound traffic on York Street shall stop before entering North 11th Street.”

Section 2. Section 10.210 is amended to read as follows:

“10.210 Three-Way Stop.

- (1) There shall be a three-way stop at the intersection of Huron and North 11th Streets. All traffic southbound on North 11th Street shall stop before entering Huron Street and all traffic eastbound and westbound on Huron Street shall stop before entering North 11th Street.

- (2) There shall be a three-way stop at the intersection of River Point Drive and North 11th Street.”

Section 3. Section 10.230 is amended to read as follows:

“10.230 Four-Way Stop.

...

- (17) There shall be a four-way stop at North 11th Street and Buffalo Street.”

Section 4. Section 10.410 is amended to read as follows:

“10.410 Parking Regulated in Inclement Weather.

(1) There shall be no parking on all marked State or Federal highways, County trunk highways, City bus routes, any industrial truck routes specified in MMC 10.750, in any municipal parking lot (with the exception of leased stalls and lots otherwise posted) or in other designated streets in the City of Manitowoc between the hours of 1:00 a.m. and 6:00 a.m. when a “Winter Parking Ban” is declared by the Mayor or designee, pursuant to subsection (2) of this section. The listing of such streets is as follows:

...

13. North 11 Street – Chicago Street to ~~Buffalo Street~~ River Point Drive.

...

41. Buffalo Street – North 5th Street to ~~North 11th Street~~ River Point Drive.

...

82. River Point Drive – North 10th Street to Chicago Street

~~823.~~ State Street – North 7th Street to North 10th Street

~~834.~~ Viebahn Street – College Street to South 42nd Street

~~845.~~ Washington Street – South 7th Street to South 26th Street

~~856.~~ North Water Street – North 10th Street to North 11th Street

~~867.~~ South Water Street – South 13th Street to Franklin Street

~~878.~~ West Custer Street – South Rapids Road to South Alverno Road

~~889.~~ Western Avenue – Meadow Lane to Clark Street

~~890.~~ Wildwood Drive – Fleetwood Drive to North Rapids Road

~~901.~~ York Street – North 7th Street to North 10¹th Street

~~942.~~ Yorkshire Lane – South 30th Street to South 35th Street”

Section 5. Section 10.490 is amended to read as follows:

“**10.490 Two-Hour Parking.** No vehicle shall be parked for a continuous period of longer than two hours between the hours of 9:00 a.m. and 5:00 p.m., except on Sundays and holidays, on the following streets or portions of streets:

...

North 11th Street. On both sides of North 11th Street from River Point Drive to Chicago Street.

...

Buffalo Street.

- (a) On both sides of Buffalo Street from North 7th Street to North 9th Street.
- (b) On the south side of Buffalo Street from North 9th Street to North 10th Street.

(c) On both sides of Buffalo Street from North 10th Street to North 11th Street.”

...

Quay Street.

...

River Point Drive. On both sides of River Point Drive from North 11th Street to Chicago Street.

...”

Section 6. Section 10.730 is amended to read as follows:

“10.730 Angle Parking. There shall be angle parking provided for on the following streets:

...

Park Street. ...

River Point Drive. On the north side of River Point Drive between North 11th Street and Buffalo Street.

...

York Street. On both sides of York Street between North 7th Street and North 11th Street.”

Section 7. Section 10.850 is amended to read as follows:

“10.850 Pedestrian Crosswalks. In addition to any marked or unmarked pedestrian crosswalks at intersections in the City of Manitowoc, pedestrian crosswalks are hereby established at the following locations:

...

(7) Across Buffalo Street midblock between North 10th and North 11th Streets.

(8) Across North 11th Street midblock between Buffalo and York Streets.

(9) Across York Street midblock between North 10th and North 11th Streets.

(10) Across River Point Drive midblock between North 10th and North 11th Streets.”

Section 8. This ordinance shall take effect the day after publication. The City Clerk shall publish this ordinance when directed to do so by the City Attorney and Director of Public Infrastructure.
