The Public Infrastructure Committee received a request back in July from a property owner on S. 22<sup>nd</sup> Street requesting the City review the possibility of converting the 900 block of South 22<sup>nd</sup> from a one-way street back to a two-way street. The Public Infrastructure Committee discussed this issue at the August meeting, and requested Engineering to bring back options and cost estimates. The options and cost estimates were brought back to the Public Infrastructure Committee meeting September 7<sup>th</sup>. The Committee requested inviting the property owners to the October 5<sup>th</sup>, 2022 meeting for further discussions.
