PARTIAL RELEASE OF EASEMENT

The City of Manitowoc, a municipal corporation, for no money but other good and valuable consideration, the receipt of which is hereby acknowledged, hereby Releases to the owners of record all of its rights, title and interest in a portion of an easement area as described as follows:

A portion of a utility and drainage easement located in Lot 49, Block 5, of the Forest Estates Subdivision No. 6 in the Southeast 1/4 of the Northwest 1/4 of Section 13, Township 19 North, Range 23 East, City of Manitowoc.

**The Partial Easement area to be released is more particularly described as follows:**

The West 10 feet of the East 20 feet of said Lot 49 excepting the South 6 feet and North 10 feet of said lot. Described area is shown on Exhibit A attached. Described area is 770 s.f . or 0.017 acres +/-.

The purpose for partially releasing the easement is to allow for the owner of said lot to construct a building expansion into a portion of the easement area.


