Hello Council President Sitkiewitz,

Today I received a message from Paul Hoffman, owner of Petskull Brewing, requesting the ability to have a portion of the tent he is renting for his approved event on June 24th to be placed proportionally into the right of way of North 11th Street near his premises one day earlier on June 23rd. Here is the relevant portion of his request:

*Happy Monday Jim! My real question is related to the show and I'm looking for your expertise. I'm encountering difficulties with scheduling the delivery of stuff I'm renting. Because the show is on a Saturday, anything I've rented/reserved are coming on Friday - apparently these places don't work on Saturdays. The beer wagon and porta potties I can move to the private lot where the show is - that's no biggie. The major issue I've got is the tent. The tent is going going to protrude probably 20 feet out onto North 11th. This was not an issue when I set this up, as I was under the impression they were setting up on Saturday after I close the road section. Now I'm going to have a tent protruding out onto North 11th on Friday. What can I do? Sorry for all of the questions with this event.*

Based on what Mr. Hoffman stated, he is requesting that the tent he rented for the approved event on June 24th be allowed to be put up on June 23rd and extend into North 11th Street. What this means is that he is requesting that North 11th Street be closed beginning on the 23rd, all of the 24th and will be back open after the cleanup from what I am assume at the latest June 25th.

After speaking with Attorney Nycz and City Clerk Reed, we all agreed that the best way to go about this would be a formal request to the Common Council to amend the original approved road closure to include June 23rd. Fortunately we meet June 19th so we can discuss Mr. Hoffman's amended request.

With your permission, this request will be placed on the June 19th Common Council agenda under Committee of the Whole. Thank you for your consideration on this matter.
