Carryforward Request from 2015 Budget to 2016

\$15,260

Request for full conversion of Springbrook database from Progress to Sequel and inversion upgrade of the software from 7.15 to 7.18. This upgrade is desperately needed by both users of the software to gain access to key features which are now customs on the current version. Due to the elimination of the custom code the city should see a reduction in our annual maintenance from custom code and is estimated to be in the \$5,000 - \$7,500 annually. In addition, the IT Department wants to migrate this from Progress to Sequel to have all major systems reside on Sequel databases.

This was scheduled to occur in 2015, but due to the Accela acquisition of Springbrook all upgrades were placed on hold.

\$15,825

Along with the Springbrook upgrade a full suite of Business Intelligence Products becomes easily accessible via the new sequel database. Providing transparency and an easy to use "Dashboard" for the public and internal users to access live city financial data. Through OpenGov we can have a public facing web page giving full access to the city's financial data in a user friendly format which will allow the user to customize the view and the specific data they wish to see all the way down to the specific check in the city's general ledger. In addition, the application allows an internal facing set of reports that will be very useful in analyzing data for budgetary purposes and to allow users to create data sets to make data driven decisions/recommendations.

I respectfully request the funds totaling \$31,085 which are available in the 2015 Data Processing budget to be carried forward to the 2016 General Fund Budget.

The City Attorney's Office is requesting carryover of the following funds from the Attorney budget:

Line: 1100-12100-418.86, Salaries and Wages - Overtime

**Amount:** \$418.86

Justification: This line is used to cover overtime expenses for the paralegal position. The paralegal will be covering half the Personnel Committee meetings in 2016 and carryover will allow us to utilize her time most effectively.

Line: 1100-12100-521200, Legal Expenses

**Amount:** \$24,370.00

**Justification:** This line is used to fund outside counsel costs. The City has continuing litigation from last year (1512 Washington Street, Menard's, Holy Family) and it would be appropriate to use funds appropriated for 2015 litigation to partially cover these expenses. We also recently had claims filed regarding 2015 events that were not filed until 2016.

Line: 1100-12100-521210, Court Costs

**Amount:** \$1,181.57

**Justification:** This line is used to fund litigation expenses. A number of cases will likely end up in litigation resulting from the 2015 Property Tax Assessment, I would ask that this amount be carried over since the events giving rise to the litigation occurred in 2015.

Line: 1100-12100-527300, Software Maintenance & Support

**Amount:** \$15,000.00

Justification: This line is used to fund our practice management software. We have not received an invoice for 2015 yet and still have expenses from 2014 that we were not charged for, so I would like to carry this line over to fund those 2015 expenses once the bills arrive.

Line: 1100-12100-532500, Registration Fees and Tuition

Amount: \$141.81

Justification: I was able to reduce expenses on CLEs by registering early and taking advantage of discounts. I would like to carry this over to fund additional training in 2016.

**Amount:** \$39,483.92

Justification: The amount bonded for Lemberger Landfill, a Superfund site, in 2015 was not entirely spent because the members of the LSRG were not able to reach agreement with the EPA and DNR on the number of new monitoring wells that should be drilled, so no wells were drilled in 2015. We have now reached a tentative agreement and I would ask that these funds be carried over into 2016 to fund the expense which was planned for 2015.

Dear Steve,

The Manitowoc Fire Rescue Department would appreciate your consideration of the following 2015 Budget Year Carry-over Requests. This request is the due diligence of the Fire Rescue Department staff keeping other line item expenditure costs fiscally responsible.

Office of Fire Department

The first request for consideration is for the amount of \$5,750.00 be carried over from account 1100-22100-534920-New Hose. These funds would be used to purchase new nozzles. The purpose for the new nozzles is for the replacement of twenty plus year old nozzles that at the time of purchase were state of the art. In the fire service our technology and tactics are always changing. The nozzles that would be purchased are called smooth bore nozzles that have less nozzle reaction and therefore can be controlled by firefighters with a greater ease of physical work in an already stressful environment.

The following requests for carry over are for funds received from grant monies and donations to the Fire Rescue Department that are required to be carried over as these are designated funds:

1. 1100-22100-581930-Grant Expenditures: \$20,317.08.
 These monies are an accumulation from grant years prior to and including 2015. These funds can only be spent on specific EMS items.



2. 1100-22100-581940-Donation Expenditures: \$2,430.50
These funds are the balance remaining of monies that were donated to the Fire Department in 2015 and over the past several years, including monies received from the Turgasen estate.

The final requests are for the following designated Capital Funds to be carried over:

- 1. 4700-22100-581400-Heavy Motorized Equipment:
  - \$157,000.00: These funds are for the purchase of a new Ambulance that was not yet finalized in 2015.
- 2. 4700-22100-581920-Radio Communication Equipment:
  - \$66,158.00: These funds are for the enhancement of our radio communications and to address concerns of interoperability and firefighter safety.
