

ORDINANCE

An Ordinance to amend Section 10.510 of the Manitowoc Municipal Code regulating Limited Time Parking in City Parking Lots.

The Mayor and Common Council of the City of Manitowoc do ordain as follows:

Section 1. Section 10.510 is amended to read as follows:

"10.510 Limited Time Parking in City Parking Lots.

~~In addition to parking meter time limits in City parking lots under MMC 10.690*, the following free parking time limits are established in the following City parking lots:~~

- (1) ~~Lot #1: Buffalo Street Parking Lot — Between North 7th Street and 8th Buffalo Streets. Spaces 1 to 12 shall be eligible for Except for reserved/leased spaces, and~~ Handicapped parking spaces, unreserved/leased spaces, and all other parking spaces shall be considered open-unlimited parking spaces. Overnight parking is only allowed as reserved/leased or established by separate ordinance/resolution.
- (2) ~~Lot #2: North 9th Street and Maritime Drive. Reserved for future use~~ All spaces shall be eligible for reserved/leased spaces. Unreserved/leased spaces shall be considered unlimited parking spaces. Overnight parking is only allowed as reserved/leased.
- (3) ~~Lot #3: Quay Street between South 8th Street and South 9th Street. Parking Lot. In the Quay Street parking lot between South 8th Street and vacated South 9th Street, commonly known as the City Hall Parking Lot, City employee parking until 5 p.m. as signed, spaces 301 to 315 and 321 are eligible for reserved/leased spaces. Handicapped parking and all other spaces shall be considered unlimited parking spaces. there are hereby created five one-hour parking spaces. Overnight parking is only allowed as reserved/leased.~~
- (4) ~~Lot #4: Quay Street between South 8th Street and South 7th Street. All spaces shall be considered unlimited parking spaces. Overnight parking is only allowed as posted. Reserved/leased spaces are not permitted.~~
- (4)(5) ~~Lot #5: South 10th Street and Jay Street. Public Safety Building Parking Lot. Except for parking spaces reserved for City -employee parking and handicapped spaces parking as signed, all parking spaces in the upper portion of the Public Safety Building parking lot~~ All other spaces shall be two-hour parking between the hours of 7:00 a.m. and 5:00 p.m. and unlimited after 5 p.m. Overnight parking is not permitted except for employee parking. Reserved/leased spaces are not permitted.
- (5)(6) ~~Lot #6: South 9th-9th Street and Franklin Streets Parking Lot. Except for reserved, handicapped and parking spaces reserved for city employee parking, City employee parking and handicapped parking as signed, a~~ All other remaining stalls shall be considered open-unlimited parking spaces. Overnight parking is not permitted except for employee parking. Reserved/leased spaces are not permitted.
- (7) ~~Lot #7: South 7th-7th Street and Jay Streets Parking Lot. Except for reserved, handicapped, and those parking spaces, designated as two-hour parking spaces between the hours of 7:00 a.m. and 5:00 p.m., all other parking spaces shall be reserved/leased spaces only. considered open parking spaces. Overnight parking is only allowed as reserved/leased.~~
- (8) ~~Lot #8: South 10th Street. City employee parking only. Reserved/leased spaces are not permitted.~~
- (9) ~~Lot #9: South 12th Street and Franklin Street. All spaces shall be eligible for reserved/leased spaces. Unreserved/leased spaces shall be considered unlimited parking spaces. Overnight parking is only allowed as reserved/leased or established by separate ordinance/resolution as posted.~~
- (10) ~~Lot #10: North 8th Street and Buffalo Street. Except for handicapped parking spaces, all spaces shall be eligible for reserved/leased spaces. Unreserved/leased spaces shall be considered unlimited parking spaces. Overnight parking is only allowed as reserved/leased.~~
- (11) ~~Lot #11: South 9th Street and Jay Street. Except for handicapped parking spaces, all spaces shall be eligible for reserved/leased spaces. Unreserved/leased spaces shall be considered unlimited parking spaces. Overnight parking is only allowed as reserved/leased.~~

- (12) Lot #12: North 7th Street and Maritime Drive. Except for handicapped parking spaces, all spaces shall be eligible for reserved/leased spaces. Unreserved/leased spaces shall be considered unlimited parking spaces. Overnight parking is only allowed as reserved/leased.
- (13) Lot #13: North 10th Street and York Street. All spaces shall be eligible for reserved/leased spaces. Unreserved/leased spaces shall be considered unlimited parking spaces. Overnight parking is only allowed as reserved/leased.”

Section 2. This ordinance shall take effect the day after publication.
