Manitowoc Lutheran High School Facilities Manager Mark Ross was present and explained that the school is requesting the commons area be designated as a no-parking zone. The current fifteen-minute parking restriction has proven difficult to enforce, and vehicles frequently park in unauthorized areas. Engineering Division Manager Greg Minikel was also present and stated that the change would require updates to existing signage, and City crews would paint yellow diagonal lines to clearly mark the no-parking area.

A motion was made to repeal the current fifteen-minute parking ordinance and to draft an ordinance prohibiting parking in the designated area.
