Thank you for your attention to this matter.

I'm requesting that the 29 (I believe) parking spots that are marked as 2 Hour in the public parking lot at the **corner of Jay & 7th street** be changed to unrestricted. These are not needed as 2 hour spots; there are plenty of those on the street. People who work downtown need these spots for all day parking during the work day. There are about 26 (I believe) unlimited parking spots available in that same lot, but they are almost never vacant, particularly between the hours of 8-10 a.m.

The 2018 parking study identified the block where I work (#239 on their map) to be the single worst block in the study zone. This would more than double the available unlimited spots in that one specific parking area. While we need more parking than this, it would certainly help, and it is a quick and easy solution.

Also, the public lot on the block between **Jay & Franklin and 9th Street** also would be a great option to alleviate the parking issue on block #239. Currently every stall in this lot is leased parking. I don't know how many of those leased spots are actually leased, but there always seems to be empty stalls there. Could you also look into making some of these leased spots unlimited if there are some available?

Additionally, I would like you to consider allowing people to lease spots on a monthly rather than yearly basis. I know several people in my same situation who would consider leasing during the winter months, but would be willing to walk to the Briess lot during summer months when there is not an event going on there. But it is my understanding that the city will not currently consider anything but annual leases.
