

## **ORDINANCE**

**WHEREAS**, Wis. Stat. § 5.15(4)(a) requires that municipalities number all wards in the municipality with unique whole numbers in consecutive order; and

**WHEREAS**, Wis. Stat. § 5.15(1)(b) maintains that all territory contained within the municipality, and only the territory so contained, on April 1 of the year of the federal decennial census shall be contained within a ward established under the division ordinance or resolution; and

**WHEREAS**, Interstate #16 Annexation was annexed into the City on June 22, 2021 and Annexation Ordinance #21-0604 adopted by the Common Council on the same date which established Ward 35; said Ordinance being subsequently recorded at the Manitowoc County Register of Deeds Office in Volume 3422, Page 420; and

**WHEREAS**, Custer #7 Annexation was annexed into the City on August 16, 2021 and Annexation Ordinance #21-0748 adopted by the Common Council on the same date which established Ward 36; said Ordinance being subsequently recorded at the Manitowoc County Register of Deeds Office in Volume 3436, Page 419; and

**WHEREAS**, S. 15<sup>th</sup> St. #2 Annexation was annexed into the City on November 15, 2021 and Annexation Ordinance #21-1135 adopted by the Common Council on the same date which established Ward 37; said Ordinance being subsequently recorded at the Manitowoc County Register of Deeds Office in Volume 3457; Page 533.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Common Council of the City of Manitowoc do ordain as follows:

**SECTION 1.** Pursuant to Wis. Stat. § 5.15(4)(a), Ordinance #21-0604 is amended to read as follows:

- A. All references to Ward 35 of the 9<sup>th</sup> Aldermanic District shall be replaced, superseded and renumbered to read “Ward 21” as so referenced on the attached map.

**SECTION 2.** In all other respects, Ordinance #21-0604 shall remain in full force and effect.

**SECTION 3.** Pursuant to Wis. Stat. § 5.15(4)(a), Ordinance #21-0748 is amended to read as follows:

- A. All references to Ward 36 of the 9<sup>th</sup> Aldermanic District shall be replaced, superseded and renumbered to read “Ward 22” as so referenced on the attached map.

**SECTION 4.** In all other respects, Ordinance #21-0748 shall remain in full force and effect.

**SECTION 5.** Pursuant to Wis. Stat. § 5.15(4)(a), Ordinance #21-1135 is amended to read as follows:

- B. All references to Ward 37 of the 7<sup>th</sup> Aldermanic District shall be replaced, superseded and renumbered to read “Ward 23” as so referenced on the attached map.

**SECTION 6.** In all other respects, Ordinance #21-1135 shall remain in full force and effect.

**SECTION 7.** This ordinance shall take effect the day after publication.

**SECTION 2.** In all other respects, Resolution #21-0605 shall remain in full force and effect.

**SECTION 3.** Pursuant to Wis. Stat. § 5.15(4)(a), Resolution #21-0749 is amended to read as follows:

- C. All references to Ward 36 of the 9<sup>th</sup> Aldermanic District shall be replaced, superseded and renumbered to read “Ward 22” as so referenced on the attached map.

**SECTION 4.** In all other respects, Resolution #21-0749 shall remain in full force and effect.

**SECTION 5.** Pursuant to Wis. Stat. § 5.15(4)(a), Resolution #21-1134 is amended to read as follows:

- D. All references to Ward 37 of the 7<sup>th</sup> Aldermanic District shall be replaced, superseded and renumbered to read “Ward 23” as so referenced on the attached map.

**SECTION 6.** In all other respects, Resolution #21-1134 shall remain in full force and effect.
