RESOLUTION

FINANCE DIRECTOR / TREASURER

WHEREAS, Mayor Justin Nickels has advised that Finance Director/Treasurer Steve Corbeille has submitted his notice of intent to retire in late December 2020 or early January 2021; and

WHEREAS, the Mayor, Council President and Personnel Committee chair recommend to move forward with the recruitment process, due to the position's role with specialized areas of finance and budgetary decisions; and

WHEREAS, the Personnel Committee at a meeting held on June 1, 2020 approved to begin recruiting and to backfill this position, including an up to two month training overlap; and

WHEREAS, the Common Council has enacted a resolution requiring 2/3 approval of the Common Council prior to filling a vacancy.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Common Council of the City of Manitowoc to approve the recruitment and backfilling of the Finance Director/Treasurer position, as an exempt position, at Grade S, all according to the Compensation Plan and Employee Policy Manual, including an up to two month overlap for training purposes, in accordance with the 2020 budget, and to backfill any vacancies created as a result of filling this position.
