### 14-641 Firefighter grievance regarding minimum staffing.

City Attorney McDaniel explained the contractual grievance procedure. Alder Hennessey invited the firefighter representatives to address the Committee. Scott Moran and Jeremy Wagner addressed at length minimum staffing in accordance with the labor contract. Fire Chief Todd Blaser joined in discussion and clarified. It was the concensus of the Committee to deny the grievance, to keep the dialogue going and to be more proactive moving forward.

Moved by Sitkiewitz, seconded by McMeans, to deny the grievance. Alder Able requested that in the denial letter it be stated that this is an issue that the City will continue to work on. The motion carried by the following vote:

### 14-1019 Residency extension for Officer VanKauwenberg.

The Committee was in agreement to approve an extension up to a year, as long as the home is on the market. Alder Brey questioned the legality of residency. Chief Tony Dick and City Attorney McDaniel advised that the residency requirement is distance in miles from the City.

Moved by Able, seconded by Schema to approve the extension. Committee briefly discussed. Able amended his motion to approve the extension up to one year as long as the home remains actively for sale.

Committee discussed the 85% starting wage of Steps 1 for 6 month probationary periods, the control point and years of experience. This position will have a starting wage of 85% of Step 1 (\$16.86/\$19.84) and then moving to \$19.84 after 6 months.
