Jeremiah,

I drove through this area today.

Normally, I try to deter stop signs.

However, in this case a stop or yield sign maybe warranted. I am not really a fan of Yield signs anymore as I do not feel that the motorists drive them correctly.

I guess I would like to have the Chief obtain the accident data for the past 3 years to see what that shows.

There is a rather significant hill on the east leg of the intersection that could be causing some line of sight issues. This may be a good reason to control it.

In addition, every other intersection along New York Ave. from N. 21st St. through N. 6th St. is controlled in one manner or another. The only other uncontrolled intersection is at N. 20th and New York Ave. which maybe sees 10 cars a day.

There are Yield signs on N. 6th St. at New York Ave. Then, there are Stop signs on Lincoln Blvd. at New York Ave. New York Ave. from N. 8th to N. 18th St. is a collector street so that every minor intersection coming into New York Ave. must stop first.

I would say that this issue is worthy of discussion at next month's Public Safety Committee meeting.
