Ald. Schlei,

I concur with Chief Reimer's recommendation to install the permanent pedestrian crossing signs and the larger ladder crosswalks at the intersection of Waldo Blvd. and North 21st St.

I have attached the link for an old August 2007 traffic count for North 23rd and Waldo Blvd. (which predates the new pool/aquatic center and the MYBA fields), so I would guess that the pedestrian counts are likely higher than the 2007 count.

I am also assuming that the pedestrian counts are similar at both N. 21st and N. 23rd St.

The cost for the 2 new pedestrian crossing signs and new square post is estimated to be \$600.

The cost for the 2 new ladder crosswalks (existing pavement markings are epoxy so DPI would not be able to do the work) is estimated to be \$2,500. The 2024 bid for the ladder type crosswalk or 12" Alternate Crosswalk was \$8.75/LF.

Total estimated cost is \$3,100.

I was hoping to repaint all of Waldo Blvd. in 2025, but I am not sure if there will be a Capital Budget approved for the Epoxy Pavement Marking Program.

If we fund the repainting of Waldo Blvd. for 2025, then the pavement marking cost will just be part of the bid project.

We could ask the contractor for 2024 if they will add on this work, but I am not sure if the unit price will stay the same. It might if they do the work at the same time, but if they have to come back a 2nd time then there will be additional mobilization costs. I think the 2024 contractor is coming to town soon.
