Good Morning Mayor Nickels,

As previously indicated, the Friends of Citizen Park Rec Center is interested in having the building we are raising funds for officially recognized as the Citizen Park Recreation Center. At this time, in the process of doing our fund-raising, we often have to use several descriptions to indicate which building we're referring to. Sometimes we must use the Armory, other times the skating rink, Rollaire and even sometimes the field house.

By virtue of this email, I, on behalf of the Friends of Citizen Park Rec Center, would like to make the following requests to you and the City Council:

1) That the name of the building we are referring to, be officially and permanently changed to the Citizen Park Recreation Center and,

2) That you and the City Council instruct the Department of Public Works to construct a sign which can use the existing uprights located in front of the former Recreation Department offices with the newly adopted name:

Citizen Park
Recreation Center

Of course, we realize that this adoption of the name won't immediately take care of the description problems we have in identifying the building, but it would be a good step in getting all citizens of the area to recognize this building by just one name so that in the future, this may be the only name this building is referred to as.
