**PROPOSED STREET VACATION AND PUBLIC HEARING ON PROPOSED CHANGE  
TO OFFICIAL MAP**

NOTICE IS HEREBY GIVEN that a public hearing will be held, pursuant to Wis. Stat. Section 62.23(6)(c), in the Common Council Chambers of the City Hall in the City of Manitowoc on Monday, **November 21, 2016, at 6:35 p.m.** for the purpose of hearing any and all interested parties in the matter of a proposed change to the Official Map to remove a portion of unimproved Edgewood Road, as shown in the sketch below.

NOTICE IS FURTHER GIVEN, pursuant to Wis. Stat. Section 66.1003(4) that a resolution providing for the vacation of a portion of unimproved Edgewood Road, described herein was introduced to the Common Council on Monday, September 19, 2016, and will be acted upon by the Common Council at a regular meeting to be held on Monday, November 21, 2016, in the Common Council Chambers of City Hall, or at a subsequent session of the Common Council. The resolution may be adopted as introduced or amended. At the same meeting the Common Council will also act upon the ordinance to amend the Official Map to remove a portion of unimproved Edgewood Road.

Copies of the ordinance to amend the Official Map and the resolution to provide for the street vacation are available in the City Clerk's office.

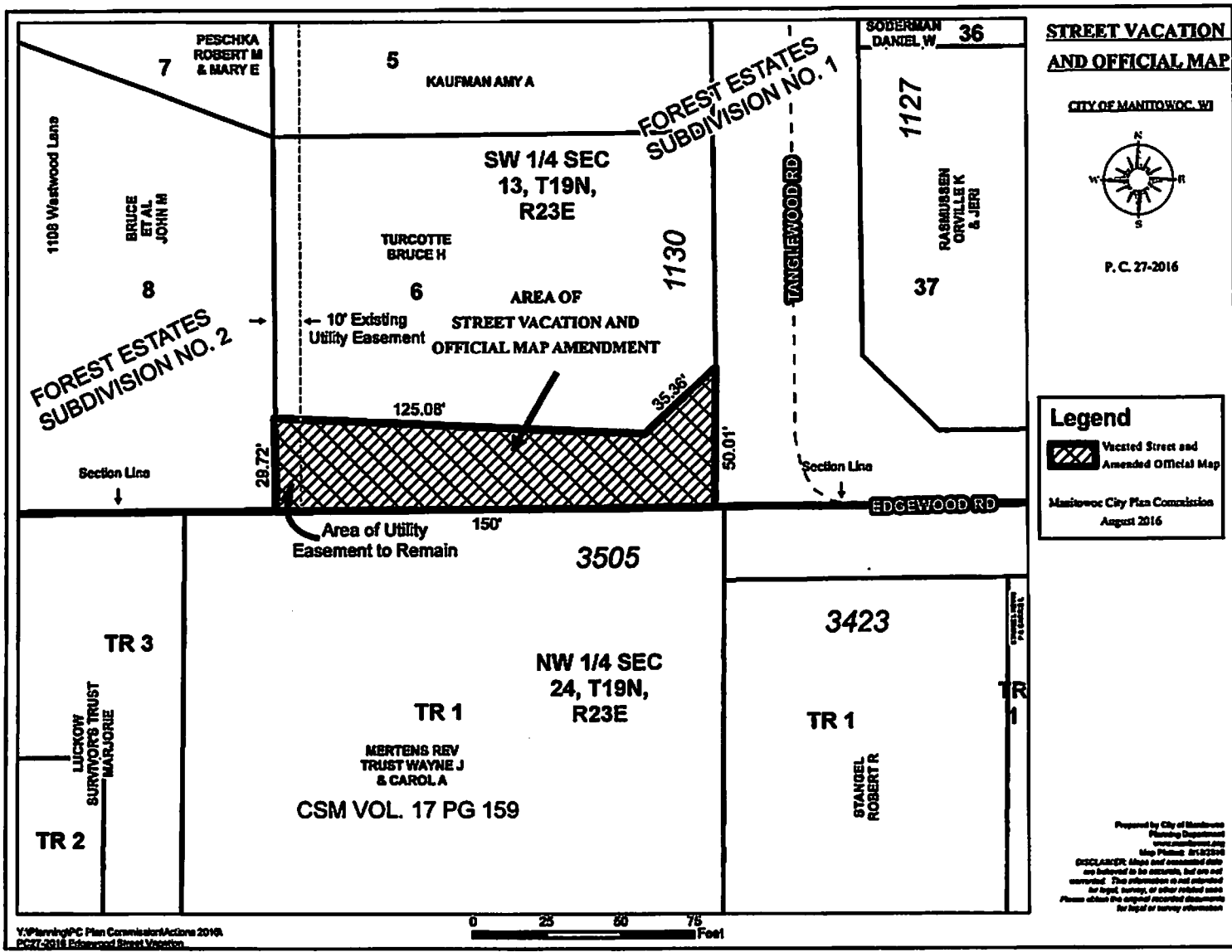

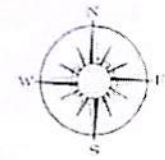

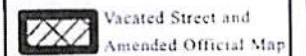
# STREET VACATION AND OFFICIAL MAP
