

CONTRACT

This contract is made and entered into this day of March, 2018, by and between Kaysun Corporation (hereinafter "Kaysun"), a Wisconsin corporation with principal offices at 5500 West Drive, Manitowoc, WI 54220, and the City of Manitowoc (hereinafter "City"), a Wisconsin municipal corporation located at 900 Quay Street, Manitowoc, WI 54220.

RECITALS

WHEREAS, Lower Henry Schuette Park, located within tax parcel 824-401-010 at 3800 Broadway Street in the City of Manitowoc, is comprised of 65.17 acres along the Manitowoc River and provides for recreational opportunities for Manitowoc residents and tourists; and,

WHEREAS, Kaysun Corporation wishes to donate outdoor exercise equipment to the City of Manitowoc, to be installed between the Shelter Picnic Area and hiking trail, to improve the recreational opportunities for the general public available at Lower Henry Schuette Park; and,

WHEREAS, the City will install the exercise equipment at their sole expense using vendors of their selection.

NOW, THEREFORE, the undersigned parties agree as follows:

- 1. Recitals. The above recitals are deemed to be true and correct.
- 2. Equipment. The exercise equipment provided shall be as outlined on the attached Exhibit A, to include various outdoor weightlifting equipment.
- Costs. The City agrees to pay all costs associated with constructing a concrete pad upon which the donated equipment will be located and for all costs associated with installing the donated equipment.
- 4. Ownership and Maintenance. The City shall assume ownership of the equipment as of its delivery at the City of Manitowoc Parks Shop and bears sole responsibility for ongoing maintenance and repairs of the equipment. The City may remove the equipment at any time at their sole expense.
- 5. <u>Schedule</u>. The donated equipment will be delivered to the City of Manitowoc Parks Shop, 1105 Fleetwood Drive, Manitowoc, Wisconsin, no later than May 31, 2018.
- 6. <u>Insurance</u>. The City of Manitowoc will be responsible for insuring the equipment after its delivery to the Parks Shop.
- 7. <u>Applicable Statutes</u>. Any provisions of the Wisconsin Statutes, Federal Law or local ordinances applicable to the work performed hereunder are deemed to be incorporated by reference and made a part of this contract.
- 8. <u>Disclaimer and Limitation of Liability</u>. Kaysun provides all donated equipment to the City on an as-is basis, but will transfer any warranties from the manufacturer to the City of Manitowoc. The City acknowledges that Kaysun will not be liable for any action in contract and tort related to the donated equipment unless the action arises as a result of negligence on the part of Kaysun or their contractors.

9. Notice and Demands. A notice, demand or other communication under this Contract by any party to the other party shall be sufficiently given or delivered and deemed delivered as of the date such notice is delivered to the party intended, if it is dispatched by registered or certified mail, postage prepaid, return receipt requested, or delivered personally and addressed to or personally delivered to:

Notice and demand given shall be effective only if and when received by the party intended and acknowledged by receipt. The above addresses may be changed at any time by any party by giving written notice in the manner provided above.

- 10. <u>Severability</u>. If any provision of this Contract is deemed by a court of competent jurisdiction to be invalid or unenforceable, the remainder of this Contract shall not be affected thereby, and such remainder would then continue to conform to the requirements of applicable laws.
- 11. <u>Amendments</u>. This Contract can only be amended or modified in writing and signed by the parties involved.
- 12. <u>Integration</u>. This Contract represents the entire understanding of the parties as to those matters contained herein. No prior oral or written understanding shall be of any force or effect with respect to matters covered hereunder.
- 13. <u>Survival of Provisions</u>. All indemnification and hold harmless obligations shall survive the expiration or termination of this Contract.
- 14. Choice of Law. This Contract shall be governed by and construed in accordance with the laws of the State of Wisconsin. All actions or proceedings relating directly or indirectly, to this Contract, whether sounding in contract or tort, shall be litigated only in the circuit court located in Manitowoc County, Wisconsin. All parties to this Contract hereby subject themselves to the jurisdiction of the circuit court for Manitowoc County, Wisconsin.
- 15. <u>Heading</u>. The section titles have been inserted in this Contract primarily for convenience, and do not define, limit or construe the contents of such paragraphs. If headings conflict with the text, the text shall control.
- 16. Remedies Cumulative. All rights and remedies hereunder are cumulative, and not exclusive, and shall be in addition to all other rights and remedies provided by applicable law. Failure to exercise or delay in exercising any right or remedy hereunder shall not operate as a waiver thereof, nor excuse future performance. No waiver discharge or renunciation of any claim or right arising out of a breach of these terms and conditions shall be effective unless in writing signed by the party so waiving. Any waiver of any breach shall be a waiver of that breach only and not of any other breach, whether prior to subsequent thereto.

17. <u>Construction</u>. All parties have contributed to the drafting of this Contract. In the event of a controversy, dispute or contest over the meaning, interpretation, validity of enforcement of this document or any of its terms or conditions, there shall be no inferences, presumption or conclusion drawn whatsoever against any party whatsoever by virtue of that party having drafted the document or any portion thereof.
