Dear City of Manitowoc,

Thank you so much for taking the time to read this letter. On January 23, 2023 I was assessed a snow shoveling violation fine for our sidewalk not being shoveled. A complaint was called in by our neighbors on only us, and no one else that had snow on their sidewalks. This was not the first time our neighbors have complained and called to complain to the city although this is the first time something like this needed to be done. For some reason our neighbors do not like us. They leave notes on our door telling us to "F" off, stop throwing garbage in their yard (even though we have never done that) and have said we will get you. He blows all his snow onto our yard when it snows to make it harder for us to shovel and snow blow every time it snows. Our neighbor knew we were out of town in Oklahoma so knew it would be a perfect time to call in a complaint on only us to try and get us in trouble. We returned from Oklahoma on January 24th at 4:00am, when at that time I shoveled the rest of our sidewalk and driveway. While we were gone, I had no idea how much snow there was at our house and we had no one in the area who could have come that day to shovel for us. As soon as I got home the morning of the 24th, I shoveled it all.

I just wanted to say we are very good members of the community. We have never had any issues with the city or anyone in the city. We are both Manitowoc school teachers that dedicate our time to helping the community. We volunteer our time to coach youth sports and try and do as much as we can for the community as a whole. This was a very upsetting time when we received this violation all because our neighbor for some reason doesn't like us. Again, there was snow and ice in front of other houses as well, but he only complained about ours knowing we were gone. Again, as soon as we got home from Oklahoma the next morning I was outside shoveling the rest.

Please take some time and reconsider the charge of the violation based on this information. I now understand how much more careful we have to be with our neighbor and we will make sure it never happens again. Thank you for your time.
