An ordinance to amend Chapters 7, 10 and 13 of the Manitowoc Municipal Code regulating fall brush and leaf pickup in the City of Manitowoc.

The Mayor and Common Council of the City of Manitowoc do ordain as follows:

Section 1. Section 7.100(2) is amended to read as follows:

Streets, Sidewalks and Public Infrastructure. 7.100 Offenses. It shall be unlawful, and it is hereby declared to be unlawful, for any person:

(2) Materials Not to Be Dropped, Scattered or Deposited on Streets or Alleys. To scatter or deposit on the streets or alleys of the City of Manitowoc any ashes, sand, earth, clay, stone, leaves, brush, grass, yard waste, or other grading materials or material collected in cleaning streets or alleys or private premises and no person, in conveying any such material on or upon any street or alley in said City, shall permit or suffer any such material or any snow to be dropped or scattered upon any such street or alley. This section shall not apply to leaves during scheduled leaf pickup.

Section 2. Section 13.010(11)(d) is amended to read as follows:

Sanitation and Recycling. 13.010(11) Management of Lead Acid, Batteries, Major Appliances, Waste Oil, Yard Waste and Tires.

(d) Yard waste may be delivered to an authorized Manitowoc County compost site or disposed of on the site where generated. The City's Department of Public Works Streets and Sanitation Division will continue to collect designated yard waste at no charge to residents during the spring cleanup and the fall leaf program pickup. These programs shall be subject to such regulations as are approved by the Streets and Sanitation Public Infrastructure Committee. No brush or yard waste for spring cleanup shall be placed for collection by the City's Department of Public Works Streets and Sanitation Division more than two weeks before a scheduled pick up. Any yard waste placed for collection by a licensed garbage hauler shall be placed in a manner acceptable to the hauler. If yard waste is to be picked up by a licensed garbage hauler, it shall not be placed for collection more than 72 hours before scheduled pick up.

Section 3. Section 10.430 is amended to read as follows:

## 10.430 Parking Regulations for Street Sweeping and Fall Leaf Pickup.

- (1) **Duration.** Beginning April 1st through September 30th of each year parking restrictions shall be in effect for the City of Manitowoc for the purpose of street sweeping. Beginning October 1<sup>st</sup> through the Friday prior to Thanksgiving for the purpose of Fall Leaf Pickup.
- (2) Street Sweeping and Fall Leaf Pickup Maps. Street sweeping and Fall Leaf Pickup maps shall be prepared and maintained by the Director of the Department of Public Works Infrastructure and kept on file as public records in the office of the City Engineer, copies of which shall be distributed to the members of the Council and filed with the Council.
- (3) Districts for Street Sweeping and Fall Leaf Pickup. The street sweeping and fall leaf pickup maps shall divide the City into areas or districts in which street sweeping and leaf pickup shall be done on the days of the week herein specified, and during which time nNo vehicles shall be parked on the street between the hours of 3:00 a.m. and 6:00 a.m. during Street Sweeping and between the hours of 7:00 a.m. and 3:00 p.m. during Leaf Pickup for the streets set forth herein, and as more specifically described below:

## **Section 4.** Section 10.440 is amended to read as follows:

## 10.440 Parking Regulations for Spring Clean-Up and Fall Brush Pick-Up.

- (1) **Duration.** The spring clean-up and fall brush pick-up shall be for a period of one week for each section or district. The spring clean-up and fall brush pick-up-shall be Monday through Friday between the hours of 7:00 a.m. and 3:00 p.m.
- (2) Maps. The spring clean-up and fall brush pick-up maps shall be prepared and maintained by the Director of Public Infrastructure and kept on file as public records in the office of the City Engineer, copies of which shall be distributed to the members of the Council and filed with the Council.
- (3) Sections for Spring Clean-Up. The spring clean-up maps shall divide the City into areas or sections in which the spring clean-up shall be done as herein specified, and during which time no vehicles, trailers, boats, dumpsters, or other obstructions shall be parked on the street in a manner which interferes with the pickup of yard waste, Monday through Friday between the hours of 7:00 a.m. and 3:00 p.m. for the streets set forth herein, and as more specifically described below:
  - Section 1: West of North 18th Street and north of the Manitowoc River will be picked up the first week in April, unless weather conditions prohibit the pick-up.
  - Section 2: West of the Canadian National Railroad Tracks and south of the Manitowoc River will be picked up the second week in April, unless weather conditions prohibit the pick-up.
  - Section 3: East of the Canadian National Railroad Tracks and south of the Manitowoc River will be picked up the third week in April, unless weather conditions prohibit the pick-up.
  - Section 4: East of North 18th Street and north of the Manitowoc River will be picked up the fourth week in April, unless weather conditions prohibit the pick-up.
- (4) Sections for Fall Brush Pick-Up. The fall brush pick-up maps shall divide the City into areas or sections in which the fall brush pick up shall be done as herein specified, and during which time no vehicles, trailers, boats, dumpsters, or other obstructions shall be parked on the street in a manner which interferes with brush pickup, Monday through Friday between the hours of 7:00 a.m. and 3:00 p.m. for the streets set forth herein, and as more specifically described below:

Northside: The area north of the Manitowoc River will be picked up the first week in October.

Southside: The area south of the Manitowoc River will be picked up the second week in October. "

Section 5. This Ordinance shall take effect on the day after its publication.
