Thanks for your patience with this.

Attached you will find the quote for a standard crosswalk system that the City has ordered. Please review, and let me know if you have any questions, concerns, or changes. I have also added a few notes below. Let me know if you want me to make any adjustments and resubmit a new quote. Thanks!

- I quoted a standard crosswalk system for 2 way traffic which will have (2) light bars facing oncoming traffic from both sides of the road. I typically recommend this so that the oncoming traffic knows why vehicles are stopping in case there is a large vehicle at the crosswalk blocking the light bar on the right side.
- If you just want (1) light bar on each side of the road facing oncoming traffic, you can deduct qty. 2 of Line Item #4.

Kaitlin from the Community Development Dept. is looking at the installation of Rectangular Rapid Flashing Beacons (RRFB's) for the south crosswalk at North 10<sup>th</sup> and Buffalo St.

Just a reminder that N. 10<sup>th</sup> St. is now Two-Way Traffic, so I believe that we just need one sign (RRFB) facing each direction.

Can you get us another quote for an RRFB to serve this south crosswalk?? Initially, I thought this was for next year, but I guess they would like to install it this year if everyone is on board with it. Thanks.

Talk to Adam and/or the Mayor about this proposed RRFB. Historically, every RRFB that has been installed has been approved by the Public Safety Committee. You should probably do the same with this one.
