Hi Greg and Curt,

MYBA is looking at improving our facilities at Citizen Park by extending the maintenance shed and adding another set of batting cages to the park. After some discussion I've drawn up a plan for the proposed site improvements.

We're expecting to add a 20'x25' extension to the existing maintenance shed for storage of equipment and supplies.

We'd like to install two new 14'x70' batting cages in the location of the current cages in the outfield of the NW field. We'd also like to move the two 14'x55' batting cages at the NW field to the area behind the shed. Greg and I once had a discussion about the area north of the shed and that the City may look at extending the parking lot at some point. Is this still a possibility or would MYBA be okay in relocating the cages there?

Please let us know if there are concerns about the locations or scope of these improvements. Also, I'm not sure exactly who this should be going through or what permitting would be required for the batting cages or the site plan – any advice would be appreciated.
