Re: Aviary conversion to Small Mammal exhibit

In the winter of 2019-2020 the birds in the aviary went missing. All signs pointed to a resident mink causing havoc on the aviary exhibit. Initially staff set out to "mink proof" the aviary which was later deemed nearly impossible. Staff brainstormed the idea to convert the aviary to a small mammal exhibit. Small mammals should be more sustainable in a mink friendly environment. Staff was able to source two porcupines and a raccoon. Staff is looking for a 3<sup>rd</sup> animal to fill the exhibit.

Currently the Aviary is a wood structure with chain link fence/mesh exterior. In order to convert the Aviary to be able to house the above animals we need to armor the inside of the wood structure to prevent the porcupine and raccoon from chewing and climbing the wood structure. Also, by preventing the animals form climbing the fence we will prevent the animals from coming in contact with patrons making it safe for patrons to view the animals.

Staff has sourced two quotes for professional contractors to perform this work, attached. The Zoo Society has agreed to pay for ½ of the exhibit conversion.

I recommend the PI Committee approve the use of funds from the Zoo donation tube to support the exhibit conversion in the amount of, not to exceed \$4000.
