Good day Mackenzie,

I am writing this note on behalf of my father, Richard Swetlik, who let me know this weekend while I was in Manitowoc visiting, about a letter from the Office of the County Treasurer (scanned copy attached to this email). It seems there are back taxes due that are stemming from a lawn cutting situation in 2019 (scanned attachment of property tax bill attached as well).

Per the conversation with my father, this was related to a situation when a city contractor was to cut a property my father owns at 1119 Menasha Ave. The contractor showed up to cut the lawn, but while the contractor was set to begin my father discussed that his son (my brother) was going to cut it that same day. The grass cutting contractor contacted Mr. Billy Hutterer who came to the property. There was then a verbal agreement with Mr. Hutterer, that if the grass was cut that day, he would drive back past the property and there would be no fee assessed for the lawn cutting. The grass was cut by my brother that same day, but it seems that the confirmation of completion was lost in the shuffle and the grass cutting fee/tax was assessed when it should not have been. I initially contacted Amy Kocian and she suggested I reach out to you.

What steps can we take to correct this situation?

NOTICE REGARDING FORECLOSURE PROCEDURE

January 17, 2023

Dear Property Owner,

Manitowoc County is beginning the process of In Rem 2023, a tax foreclosure action on parcels which have real estate taxes more than two years delinquent. The enclosed statement indicates your parcel(s) is included in this process. At this point, you have three options:

1. Pay off all delinquent taxes by February 24, 2023, OR
2. Pay off 2019 (and prior year) taxes AND sign an agreement by February 24, 2023 to make monthly payments on remaining delinquent taxes, OR
3. Do nothing at all which may result in Manitowoc County taking the foreclosed property in September or October of 2023

If no payments are made on the delinquent taxes, an In Rem foreclosure action will be filed in Manitowoc County Circuit Court sometime during May in which your unpaid parcel will be published three times in the Herald Times Reporter. Also, your parcel will be charged for the cost of a title search as well as court costs, publication charges, guardian ad litem fees and recording expenses.

Please note that once the foreclosure action is filed in Circuit Court, the only way to remove your parcel from the foreclosure action is to pay all delinquent taxes and interest from all years. If you do nothing, the County may obtain legal title to your parcel through this In Rem action.

There are a number of steps built into this process that are meant to help you from losing your property. If you have filed bankruptcy, are encountering other struggles such as health problems, divorce, or you are trying to sell your property, please contact our office as soon as possible. These are situations that we need to know about to help you avoid tax foreclosure.

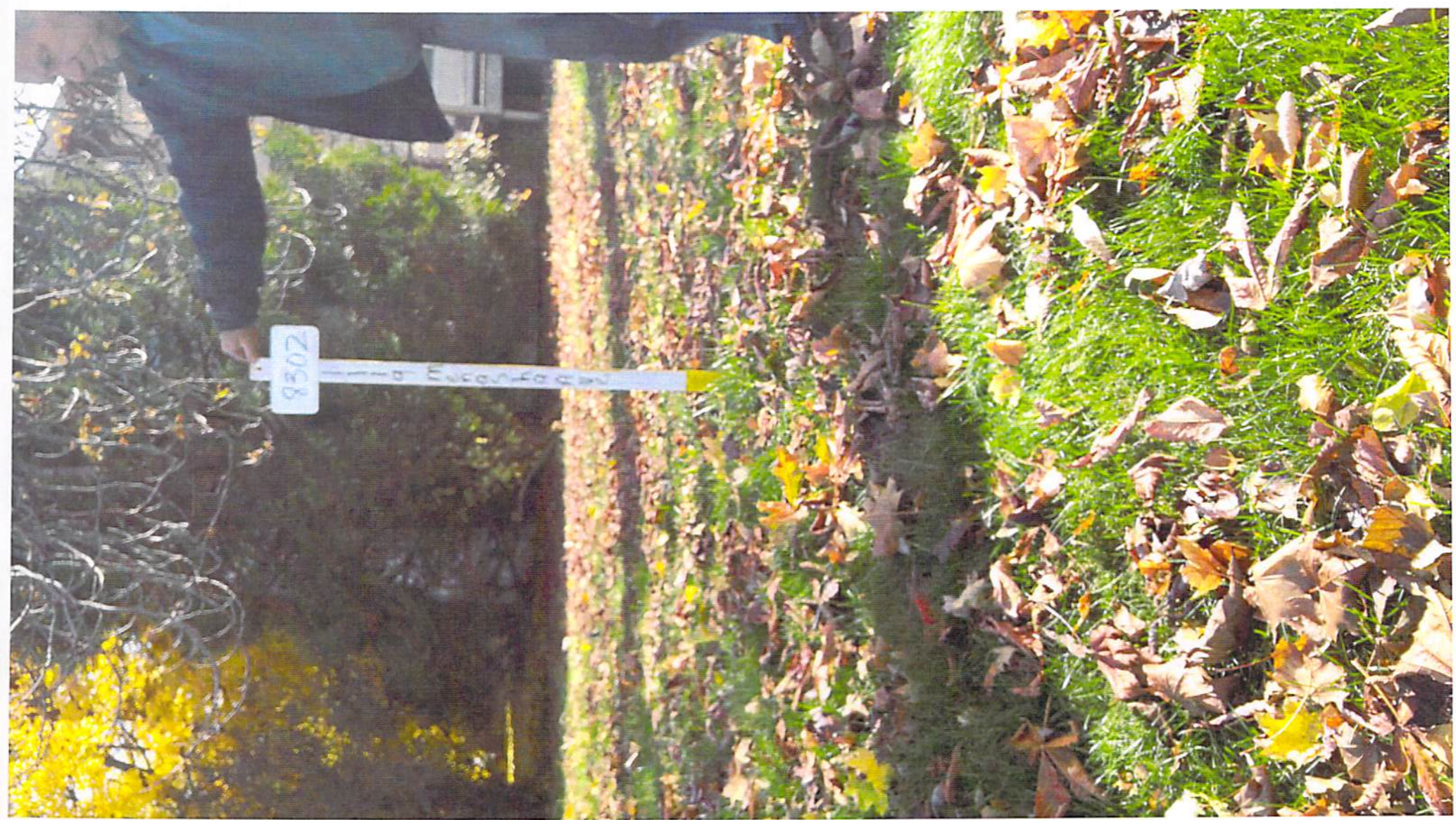
