RE: Correction of Error – Wisconsin Public Service Corp, Parcel # 000-120-070,

The parcel listed above has been owned by Wisconsin Public Service Corp for many years but has been assessed for many years. They said they filed for exemption prior to the board of review for the 2020 year. The first copy that I saw was on August 8th, 2020 when Mr. Kendrick Colin reached out to our office. We flagged it for a review for 2021 since 2020 board of review was already complete. Mr. Colin did receive a tax bill and reached out to us again asking this to be exempt for 2020 as this should not be taxable. I did contact the Wisconsin Department of Review for guidance on this issue and they confirm that this should have been exempt for 2020. This occurred in 2021.

There is a correction method for this situation. The correction falls under Wisc. Stats 70.43, sharing and charging back of taxes due to palpable errors. After the tax roll has been delivered to the treasurer of the taxation district, the governing body of the taxation district may refund or rescind in whole or in part, any general property tax shown in the tax roll and this includes any property that is exempt by law from taxation. The Correction of Error form will be included in the 2021 roll book. The City Clerk will need to file form PC-201 with the DOR no later than October 1st to request the tax refund.
