Hi Mike.

Here is a proposed agreement for the LED Pedestrian Crossing signage that you are requesting.

This is the document that would be executed if everything is approved and signed.

The cost from our supplier (Decker Supply) for the current signs at Alliance Laundry (quote from July 18, 2022) was \$8,329. However, that was for 2 crosswalks or 4 LED signs. This cost did not include the City staff time for installation. That usually adds a couple hundred.

Therefore, we would estimate yours to be about ½ the cost, plus any price increases, and there will be some added costs from the City for our electrician/traffic signal technician to install the two signs.

I would estimate that you will be at about \$4,500 - \$5,000 for the 2 signs.

I will have to get an official quote from Decker Supply.

Let me know if you and Jimmy are the appropriate persons to sign the agreement. If not, please get me the names and titles of the people that will sign the agreement. Thanks.
