Subject: Walkabout at Lower Schuette Park

Chad, Bruce, Ken, Lee (city councilman) and I met at Lower Schuette Park to discuss options for a reroute of the trail. The large hill with uneven, high, steps and the opposite side with a rain run-off problems were the concerns. A possible switch back and a walk along a ridge offers a solution to the steps. The side with the drainage problem has several solutions: 1. fix the run-off flow by removing the railroad ties that hold the water on the trail. 2. Reroute the trail on either side of the existing trail.

Chad has indicated that the city is in the process of a major planning objective to connect several of the city trails. For example, a bridge over the river to connect to Manitou Park with Schuette Park is one possibility. He would like the IATA

involved in the planning process. I suggested that Tim and either Kevin or Brad should also attend since the connections could affect the route of the IAT through Manitowoc.
