In addition to drafting legislation and reviewing contracts as requested by City departments, the City Attorney's Office has worked on the following projects and initiatives since my April 1, 2022 update:

#### **Environmental Remediation**

- Lemberger Landfill: Work continues as planned.
- Gravel Pit: Newell cost recovery for 2021 has been received. Watermain project continues. The township contract is in a position to be settled
- WPS Superfund Site: No update.
