#### Brief Description (or other problem not listed)

To whom it may concern,

Living on north 11th street for the past few years has not been too much of a hassle, as a one way street, now that it is a two way street I feel as if we need some "Slow" signs and crosswalks to be able to cross the street. There is a crosswalk on N 11th and Huron (crossing the street from the A Store to CyberWorks), but then there is no crosswalk until you get down to 10th and Water(by Tower Tavern)--we have no way to safely cross the street to get to the park using either Water St. or St. Clair. Having two (soon to be three) small kiddos, the park right by us (Riverview Park) is an incredible asset to the neighborhood, the issue is trying to cross the street to get to it. Now that it is a two way we obviously have to check for traffic both ways (as we did as a one way even) but the issues we come across are 1)knowing where to cross, and 2)people flying by in their vehicles above 25 MPH. If they are flying by at these speeds, I certainly don';t want to enter the street to cross with my children. Please, can we discuss getting some "SLOW" signs, "Children at play" or even "driveways around curve"--something that will (hopefully) help people understand they need to slow down in the area. Not only do we have a hard time trying to safely cross the street, my husband and I have almost been hit by another vehicle more times than I can count just trying to exit our driveway because people come flying around the curve/corner at speeds much higher than even 30 MPH. Since it has been a two way, I go between backing out of my driveway or pulling out forward and no matter which way I exit my driveway if people are going faster than the speed limit they suddenly have to hit the brakes because of how fast they are going, and as I stated above we';ve almost been hit on multiple occasions. I feel this is a big safety concern, not only for my family but the other families in the area as well as families or individuals walking their animals. Thank you for your time and consideration in this matter, I look forward to a response. Enjoy your day!
