- 3. That notice of a Nonrenewal Hearing on June 25, 2024 was provided to the applicant, Leslie O's LLC, by personal service on June 16, 2024 by serving the registered agent. Notice was also sent to the members of the LLC via registered mail.
- 4. That a hearing was held, pursuant to Wis. Stat. 125.12(3), on June 25, 2024, before the Common Council of the City of Manitowoc.
- 5. That all material allegations in the Complaint, also identified as the report of Deputy Chief Pusel, attached hereto, are true and correct.
- 6. That Roger Burt was not listed on the application.
- 7. That Roger Burt is a member of Leslie O's LLC.
- 8. That Roger Burt is a convicted felon.
