
Dear Mayor and Common Council:

Doneff Holdings LLC has requested a change to the official map west of Mirro Drive and south of East Albert Drive to accommodate the sale of 3.2 acres for an assisted living complex. After the 3.2 acres is sold there will be approximately 13 acres remaining and running west from Mirro Drive to north of Stangel School. The Doneff family is interested in donating this land to the City of Manitowoc if the City would be interested in owning the land for any purpose that the City deems appropriate.
