ORDINANCE

An Ordinance to amend Section 10.390 of the Manitowoc Municipal Code regulating parking.

The Mayor and Common Council of the City of Manitowoc do ordain as follows:

Section 1. Section 10.390 is amended to read as follows:

"10.390 Parking Prohibited.

It shall be unlawful for the operator of any vehicle to park such vehicle in any of the places where parking is prohibited by Wis. Stat. Ch. 346, except to comply with the directions of a traffic officer or traffic control signal or sign, or to park upon any portion of the following designated streets or places:

...

South 13th Street. There shall be no parking on both sides of South 13th Street from Grand Avenue to the South (Dead End).

..."

Section 2. This ordinance shall take effect the day after publication.
