Dear Greg,

I am sending this letter as a follow-up to our phone conference on Thursday afternoon, March 29, 2018. This letter also serves as Amendment #1 to our current Contract with the City for the Pavement Replacement Project on Calumet Avenue. It is our understanding that the City is proposing to make additional modifications to the intersection of South Rapids Road and Calumet Avenue that are not currently included in our Contract. These include the modification and replacement of traffic islands and medians, and modifications to the existing traffic signals. These improvements will be in general conformance with the attached preliminary drawing provided by the City.

Scope of Services

McMahon Associates Inc. will provide the following additional services for the intersection:

- Modify the plan and profile sheets and paving details to include the island and median modifications.
- Modify the traffic signal details to include the relocation and modifications to the existing traffic signal equipment.
- Provide additional special provisions and bid item quantity calculations for inclusion in the City's bid documents.

Compensation

McMahon Associates estimates that the cost for completing these additional services at \$3,400. All costs and services will be in accordance with the General Terms & Conditions of the original Contract Agreement.
