The Finance Committee of the Common Council having conducted a hearing on Thursday, February 9, 2017, in the above matter, pursuant to Wis. Stat. §125.12, regarding the Revocation of Scorpion's "Class B" Retail Intoxicating Liquor and Fermented Malt Beverage License; and

Scott Luchterhand, Assistant Police Chief having appeared as the complainant, and Jorge A. Ibarra having appeared as the Licensee and Owner of Scorpion, in response to the Summons and Complaint for Revocation of Scorpion's "Class B" Retail Intoxicating Liquor and Fermented Malt Beverage License;

The Finance Committee hereby makes the following Findings of Fact, Conclusions of Law and Recommendation:

## FINDINGS OF FACT

- The Licensee currently holds a "Class B" Retail Intoxicating Liquor and Fermented
  Malt Beverage License.
- The Licensed establishment, Scorpion Bar and Grill, has been the site of serious
  incidents stemming from the control of this establishment, problems with patrons,
  employees and management, which substantially relate to the circumstances of their
  licensed activity.

On February 9, 2017, Assistant Police Chief Scott Luchterhand recommended to the Committee that the license for the operation of Scorpion be revoked, which recommendation included a July 31, 2016, incident in which a physical assault of a patron occurred within Scorpion involving approximately five or six individuals and which resulted in one person requiring emergency medical care. Despite the size and severity of the physical assault, no one from Scorpion contacted law enforcement at any time to report or stop the incident. Since the granting of the license in July of 2015, there have been several more law enforcement contacts with problems at or stemming from Scorpion including repeated citations for permitting patrons after bar close and for permitting minors to loiter within the premises.

It is believed that Jorge Ibarra has failed to make a concerted effort to improve the operation of this establishment, given the history of violations relating to this establishment, which is not consistent with the responsibilities granted with a "Class B" Retail Intoxicating Liquor and Fermented Malt Beverage License.

- 3. The Licensee maintains a disorderly or riotous, indecent or improper house in violation of Wis. Stats. §125.12 (2).
- 4. The Licensee does not possess the qualifications required under this Chapter to hold the license.
- 5. Pursuant to Wisconsin Statutes Section 125.12 (2)(b), the Committee finds the allegations of the Complaint as true.

## **CONCLUSIONS OF LAW**

Based on the Licensed establishment's numerous, serious incidents stemming from the control of this establishment and which substantially relate to the licensed activity, as listed in paragraph 2 of the Findings of Fact, Scorpion Bar and Grill, owner, Jorge A. Ibarra, does not

possess the qualifications to hold a "Class B" Retail Intoxicating Liquor and Fermented Malt Beverage License under Chapter 125 of the Wisconsin Statutes.

## RECOMMENDATION

The Finance Committee hereby recommends that the license of Scorpion Bar and Grill be revoked.
