Shawn,

The pavement markings should be a non-issue. I told the P.S. Committee that we will just include the double yellow epoxy pavement markings in the 2024 bid. I would estimate the cost to be about \$500 plus or minus. This will just be part of the 2024 Epoxy Pavement Markings (Painting) Capital Budget.

I have received some quotes from Decker Supply for the LED Curve Signs. See attached quotes.

One is for a sign that would flash 24/7. Probably not what the neighborhood would want. This would be flashing in their windows all night long every day.

The radar activation quote would be the preferred choice in my opinion.

Remember, the cost proposals are for two signs, one in each direction. The problem only seems to be in the northbound direction. Therefore, to get one LED Curve sign with the radar activation would be about \$2,500 - \$2,600 plus some additional costs (couple hundred dollars maybe) for the DPW crews and Mark DeZeeuw to get everything installed and functioning.

This is what I told the P.S. Committee already.

I would not recommend putting a curve arrow or chevron arrow sign between the trees at this site. For one thing, it will likely get hit and we will be replacing the sign. The 2nd concern is that we will not get sufficient sun light to charge the batteries due to the trees/leaves blocking the sun for the solar panels.
