City Attorney McDaniel advised the Committee that ordinance 16-0430 changes the appointments of members on the Common Council to various boards and commissions from members of specific standing committees to members at large of the Common Council. The ordinance also eliminates defunct boards and commissions that no longer meet, and updates job titles and duties to reflect the City's current organizational structure.
