- Police Chief Nick Reimer stated that the glass devices are strictly used for drug use. An ordinance to stop the sale of glass smoking devices would be very helpful to the Police Department. The committee would like the City Attorney and the Chief of Police to work together on drafting an ordinance similar to the one that the city of Hudson's Police Department has. This item will be reviewed again at the August meeting.
