## NOTICE

RE: Animal Declared Dangerous Pursuant to Manitowoc Municipal Code 14.020(3)

Dear Ms. Vallejo,

The City of Manitowoc conducted an investigation and determined that your dog "LUNA" meets the definition of a "prohibited dangerous animal" pursuant to Manitowoc Municipal Code 14.020(2)(c). A copy of MMC 14.020 is enclosed for your review, but the operative section states that a "prohibited dangerous animal means any of the following: ... "Any animal that inflicts bodily harm to a person on public or private property." (See MMC 14.020(2)(c)2).

"LUNA" inflicted bodily harm to a boy while he was riding his bike on 8-25-2023 near your residence. "LUNA" bit the boy on his right calf. On 11-19-2024 "LUNA" bit a woman in the right calf and back left thigh while she was walking to church near your residence. Therefore, you are in violation of this ordinance. Please ensure that your dog is kept under control and causes no further damage, threats, or injury to the safety and welfare of the people or property of the City of Manitowoc until you comply with this Order. Failure to comply will result in forfeitures not less than \$50.00 nor more than \$500.00 for a first offense and not less than \$200.00 nor more than \$1,000.00 for any subsequent offense. Each and every day that such violation continues shall be considered a separate offense. (See MMC 14.020(3)h).

## **ORDER**

By the Authority granted pursuant to City Ordinance MMC 14.020(3), you are hereby ordered to remove your dog "LUNA" from the City limits of Manitowoc. Once removed, "LUNA" is no longer allowed to be back in the City of Manitowoc, ever. You will be given forty-eight (48) hours from the receipt of this notice to permanently remove this animal. If you fail to take immediate and appropriate action to remove this animal, the City of Manitowoc will issue citations for each day beyond the forty-eight (48) hours that you remain in violation of this Order.
