RE: Dispute recent Snow Shoveling Violation (Parcel# 000-263-030)

The City of Manitowoc sent our client (B&B Living LLC) an invoice for a Snow Shoveling Violation. We firmly believe the \$300 fine is not justified based on the photo provided along with the invoice. We immediately called the city once we opened the documents to inquire what the concern was to mail the owner a \$300 fine. The photo within the documents is of the front of a property we manage on behalf of the property owner showing both sidewalks and walkways shoveled. This property, like all our multifamily properties in and around Manitowoc, has a hired local Manitowoc professional snow removal company to perform snow removal duties each time a snow fall occurs.

As you can see in the photo the sidewalks and walkways are cleared profess onally, not just shoveled lightly, (e.g. leaving a thin or small layer of snow ice on the sidewalk) but cleared to dry or damp concrete. When we spoke to the city, we were advised the reason for the \$^0.00 Snow Shoveling Violation was the small section of private walkway that the wind had blown the snow back over. As you are aware, during snow storms the goal is to make a safe and accessible path (walkways, sidewalks, parking lots, etc.) for our tenants and the community in general, however we cannot control blowing snow, nor the timing of a photo taken of a temporary issue. We firmly believe this \$300 fine should be removed as the proof of intent and effort is clearly visible, and the result of blowing snow in a specific time frame produced this violation.

We have managed this property all winter long and have not had any previous concerns like this arise. This good track record of snow removal aligns with the small section of snow cover being a fluke event. We fully understand that this \$300 fine also may have been in reaction to a tenant, tenant's family or friend, or local neighbor that called in to complain due to the small section of snow cover on the private walkway. We can certainly respect their frustration and will always work to provide a better service. We do not believe this \$300 fine is justified and we respectfully ask that you please reconsider the violation.
