Electronic Leak Detection System

The Red Jacket Electronic Leak Detection for the fuel system at DPW failed and we have moved to the temporary backup mechanical system. The Red Jacket System electronic system we have is obsolete and parts are no longer available. We have received three quotes for a replacement electronic leak detection system. The low quote was \$4,997.78 plus the .1 risk management software of \$1,440.00 for a total of \$6,437.78. The UST Recovery Fund would be used for this repair which had approximately \$11,000 at the end of 2013.

I recommend entering into the attached proposal with Walt's Petroleum Service Inc., the low quote, for this work.
