**A. Fricke Weigel gave a summary of what the Friends of the Aquatic Center are talking about doing as Phase 3 of the Aquatic Center. On the east side by sand play area they are looking at incorporating three different features, a splash pad, pavillion/shelter, and a warming pool. The Friends group would like permission to access the property for the studies. Friends of the Aquatic Center will pay for everything and present findings back to the committee. Moved by McMeans to give the Friends of the Aquatic Center access to the Aquatic Center property to evaluate adding additional amenities to the Aquatic Center. Seconded by Schema. Motion carried by the following vote:**

C. Scheinoha gave a summary on updating the agreement with a three year term. He felt the garden was a success. A. Daug's stated the garden had a very successful first year. They created 50 raised beds. 30 beds were rented for the season. 20 of them were used for on-site education. Over 300 children visited the garden utilizing their learning programs and activities on-site. These 20 beds produced 1,330 pounds of produce that was donated to various local food pantries. A. Beatty gave a summary of the project mission - getting students involved and giving back to the community. She reviewed past projects and explained how they determined this year's project. The students brainstormed projects and voted on a dog agility course. They evaluated two locations, the dog park on the containment area and Indian Creek Park. Indian Creek Park was chosen because it is close to humane society. They looked at courses and the intermediate course was chosen. They discussed building the course and decided that for durability and maintenance the Bark Park Equipment would be a better alternative. Currently students have raised \$2,205 through various fundraising. The cost on the website is \$5,992. It is close to kennel club also. Moved by McMeans, seconded by Sitkiewitz to approve the site. Motion was carried by the following vote:

Braun Building said they would be willing to donate supplies. The Committee would like some firmer numbers brought back before committing to the \$3,000.
