Hi Scott,

I'm working on an item that should probably go to the Finance Committee. When the City/IDC provided an industrial RLF loan to Kaysun Corp. last year, I hired Andy Steimle to help us create some updated loan documents. Andy's strong recommendation was to reform the IDC as a non-stock corporation to provide an additional layer of protection to the city for these industrial loans. I have the documents prepared to accomplish that — attached.

A bit more on the history for context... The IDC went delinquent as a recognized corporation in 1997. I have asked the IDC why this was done, and no one recalls any specific reasons. Dave just felt it was no longer necessary. The total fees to reinstate the IDC would be \$245. The annual fee then drops back to the normal rate of \$10 per year. All we would have to do then to maintain that status is hold one of their regular meetings as the "annual meeting" and handle the related agenda items as stated in the by-laws. Pretty straightforward.

This can go on the April Finance Committee and then hopefully the April Council meeting. Thanks, and please let me know if you have any questions.
