Brief Description (or other problem not listed)

I travel down Wisconsin Avenue twice every weekday and I am very concerned about the lack of any intersection signage at the corners of Wisconsin Ave and 12th/13th/14th/15th Streets. These four intersections have no traffic control signs on either street, so I witness an "almost" accident at least once a week. Because this is a residential area there are often cars, trucks, campers, and even a boat parked on the streets near the corners, making it very difficult to see any traffic coming. There is also one corner with a small hill that obstructs your view. This is also a common walking route to Wilson Middle School so there are young students trying to navigate these unmarked intersections daily. Without stop or yield signs on any corner of all four of these intersections, I worry that there will be a serious accident. I would like to request that stop or yield signs be installed immediately to help prevent any injuries from happening. Thank you!
