ORDINANCE



An Ordinance amending Section 7.010 of the Municipal Code entitled: "Street Names and Numbers".

The Mayor and Common Council of the City of Manitowoc do ordain as follows:

SECTION 1: Section 7.010 of the Municipal Code is amended to include the following:

"The street located in the SW ¼ of the SW ¼ of Section 16 and the SE ¼ of the SE ¼ of Section 17 all being in Township 19 North, Range 24 East, City of Manitowoc and more particularly described as beginning at the intersection with Reed Avenue and E. Reed Avenue to its terminus at E. Waldo Blvd to be renamed from Johnston Drive to Bayshore Drive, all according to the attached map.

SECTION 2: This Ordinance shall take effect on August 1, 2020.

SECTION 3: The City Attorney is authorized to make all appropriate revisions to the Municipal Code as a result of this name change.
