
Dear Mayor and Common Council:

ORDINANCE

An Ordinance to amend Section 22.010 of the Manitowoc Municipal Code regulating "Official Map – Master Subdivision Plans".

The Mayor and Common Council of the City of Manitowoc do ordain as follows:

<u>Section 1</u>. Section 22.010 is amended to read as follows:

"The Official Map System of the City of Manitowoc is herewith amended being in the Northeast ¼ of the Northwest ¼ Section 29; also the Southeast ¼ of the Southwest ¼ Section 20, Northeast ¼ of the Southwest ¼ Section 20, Northwest ¼ of the Southwest ¼ Section 20, Southwest ¼ of the Southwest ¼ Section 20, Southwest ¼ of the Southwest ¼ Section 20, Northwest ¼ of the Northwest ¼ Section 20; also the Northeast ¼ of the Southeast ¼ Section 19; also the Southwest ¼ of the Southwest ¼ Section 17, Northwest ¼ of the Southwest ¼ Section 17 all being in Township 19 North, Range 24 East, City of Manitowoc, Manitowoc County, Wisconsin and all according to the attached map."

<u>Section 2</u>. This ordinance shall take effect the day after publication.
