Requesting Funds from 2019 Marina Dedicated Fund for Furnace Replacement and

Light Fixture Replacement

One of the heaters in the High Bay area at the Marina failed. Two quotes were received for the replacement. Manitowoc Heating \$6,411.50 and Schaus \$8,604.00.

Lights fixture ballasts in the large storage building at the Marina are bad and are hardwired in. The most cost effective solution is to replace the ballasts with new LED ones. Two quotes were received for the replacement. Hubbartt Electric \$4,700.00 and Nichols Electric \$5,400.00.

I recommend the following:

- 1. Replace the failed heater in the High Bay area at the Marina with the lowest quote, Manitowoc Heating.
- 2. Replace the lights in the large storage building at the Marina with the lowest quote, Hubbartt Electric.

The following proposal is in regard to the replacement of the infrared tube heaters that serve the North end of the High Bay service building that are currently out of order. We will provide pricing to replace the existing units with Quality Calcana tube heaters with similar design and capacity for your consideration including the following:

Infrared Tube Heaters: High Bay

We will remove and dispose or the existing tube heaters and we will furnish and install 2 Calcana SR tube heaters. The heaters will be installed in the same locations and configurations. Connection will be made to the gas lines and they will be tested. We will vent the heaters in the same fashion with new pipe and fittings to the existing double wall vent stack. New intake combustion air piping will be installed. We will install new thermostats and related low voltage wiring and a complete start up procedure will be performed.
