BILL OF SALE

WHEREAS, Goodwill Industries of Wisconsin, Inc. ("Goodwill") has built and paid for a baseball field and related facilities, commonly known as the Goodwill NCW Miracle League Field of Dreams at Dewey Street Park, for use by individuals with disabilities (the "Facilities"); and

WHEREAS, the Facilities are located on real estate which is a part of Dewey Street Park, a municipal park owned by the City of Manitowoc; and

WHEREAS, Goodwill now desires to convey to the City of Manitowoc all of Goodwill's right, title and interest in and to the Facilities so that the Facilities shall become the property of the City of Manitowoc and part of the amenities available to the public at Dewey Street Park,

NOW, THEREFORE, in consideration of the sum of\$1.00 and other good and valuable consideration, the adequacy and receipt of which consideration is hereby acknowledged, Goodwill hereby transfers and conveys to the City of Manitowoc all of Goodwill's right, title and interest in and to the Facilities free and clear of liens and encumbrances created by Goodwill, but subject to municipal and zoning ordinances and agreements entered under them, recorded easements for the distribution of utility and municipal services, recorded building and use restrictions and covenants, and other matters of record in the Office of the Register of Deeds of Manitowoc County, Wisconsin.

This Bill of Sale shall bind Goodwill and Goodwill's successors and assigns and shall benefit the City of Manitowoc and then City of Manitowoc's successors and assigns.

IN WITNESS WHEREOF, Goodwill, by its duly authorized representative, has executed and delivered this Bill of Sale as of the date set forth below.
